Certified Question of State Law, United States District Court, Southern District of Ohio, Eastern Division, No. 2:19-CV-4466. On review pursuant to S.Ct.Prac.R. 9.05, the court will answer the following questions: "(1) Whether the right to referendum set forth in Article II, Section 1 of the Ohio Constitution guarantees those circulating petitions in support of a referendum a full ninety days solely for the purpose of circulating petitions? (2) If so, whether R.C. 3519.01 violates the Ohio Constitution by shortening the ninety days to accommodate the fair-and-truthful review? (3) If the Ohio Constitution guarantees a petitioner ninety days to circulate petitions, whether the number of days attributable to a petitioner's own errors in submitting a referendum petition under R.C. 3519.01 is "credited" to the petitioner, or deducted from the ninety days? (4) Whether a petitioner who does not claim to

be "aggrieved" by the fair-and-truthful determination and thus fails to appeal the denial of a certification under R.C. 3519.01(C) is entitled to credit toward the ninety days for the time spent fixing deficiencies in a fair-and-truthful statement? (5) Whether a petitioner gets credit toward the ninety days for the time before, or between, a petition submission when the Attorney General and Secretary of State do not have a petition to review and consider under R.C. 3519.01?"

Petitioner shall file its merit brief within 40 days, and the parties shall otherwise proceed in accordance with S.Ct.Prac.R. 16.02 through 16.04 and S.Ct.Prac.R. 9.07.
