# 2019-0518. State ex rel. Frank v. Clermont Cty. Prosecutor.

In Mandamus. Sua sponte, alternative writ granted. The following briefing schedule is set for the presentation of evidence and filing of briefs pursuant to S.Ct.Prac.R. 12.05: The parties shall file any evidence they intend to present within 20 days, relator shall file a brief within 10 days after the filing of the evidence, respondent

shall file a brief within 20 days after the filing of relator's brief, and relator may file a reply brief within 7 days after the filing of respondent's brief.

### 2020-0155. State ex rel. Gordon v. Summit Cty. Mun. Court.

In Mandamus and Prohibition. On respondents' motion to dismiss amended complaint. Motion granted. Respondents' motions to declare petitioner a vexatious litigator, "motion to strike petitioner's motion to deny & in contra to respondents' motion to dismiss and motion to declare petitioner vexatious litigator," and motion for leave to file response in opposition to motion for leave to file second amended complaint denied. Relator's motion for leave for an order to file response to respondents' response, motion for leave to file second amended complaint pursuant to S.Ct.Prac.R. 12.04, S.Ct.Prac.R. 3.13, and Civ.R. 15(A), and motion to deny respondents' motion to dismiss and motion to declare petitioner vexatious litigator denied. Relator's motion to deny respondents' motion to strike petitioner's second amended complaint denied as moot. Respondents' motion to strike second amended complaint, "amended motion to strike motion in response to respondents' motion to dismiss and motion to declare petitioner vexatious litigator," and motion to strike petitioner's motion for leave to file second amended complaint denied as moot. Cause dismissed.

Kennedy, French, and Donnelly, JJ., concur.

In Prohibition. On relators' motion for sanctions against legal counsel for intervening respondents pursuant to S.Ct.Prac.R. 4.03(A). Motion denied.

# 2019-1572. State v. Taylor.

Fayette App. No. CA2018-11-021, 2019-Ohio-3437. On appellant's motion for order or relief. Motion granted.

#### 2020-0549. State v. Jarvis.

Muskingum App. No. CT2019-0029, 2020-Ohio-1127. On review of order certifying a conflict. The court determines that a conflict exists. The parties are to brief the issue as stated in the court of appeals' April 17, 2020 entry: "Whether Ohio's Sub.S.B. No. 231, 'Sierah's Law,' R.C. 2903.42 et seq., creating a violent offender database, which became effective March 20, 2019, violates Section 28, Article II of the Ohio Constitution, Ohio's constitutional prohibition on retroactive statutes, when retroactively applied to an offense that occurred before March 20, 2019." The conflict case is *State v. Hubbard*, 2020-Ohio-856, \_\_ N.E.3d \_\_ (12th Dist.).

Appellee's motion to dismiss denied. Appellee's motion for appointment of the Ohio Public Defender as counsel for appellant granted.

#### 2020-0625. State v. Hubbard.

Butler App. No. CA2019-05-086, 2020-Ohio-856. On review of order certifying a conflict. The court determines that a conflict exists. The parties are to brief the issue as stated on page 3 of the court of appeals' May 14, 2020 entry: "Does retroactive application of the violent offender database enrollment statutes codified in sections 2903.41 through 2903.44 of the Revised Code, commonly known as 'Sierah's Law,' violate the Retroactivity Clause of the Ohio Constitution, as set forth in Article 11, Section 28 of the Ohio Constitution?" The conflict case is *State v. Jarvis*, 2020-Ohio-1127, \_\_ N.E.3d \_\_ (5th Dist.). Sua sponte, cause consolidated with 2020-0544, *State v. Hubbard*.

#### APPEALS ACCEPTED FOR REVIEW

# **2020-0341.** Lycan v. Cleveland.

Cuyahoga App. Nos. 107700 and 107737, 2019-Ohio-3510. Appeal accepted on proposition of law No. I and cross-appeal not accepted.

Kennedy, J., would accept the appeal on both propositions of law and would accept the cross-appeal.

French, Donnelly, and Stewart, JJ., would not accept the appeal.
