MOTION AND PROCEDURAL RULINGS

2019-1457. Cincinnati Bar Assn. v. Burgess.

On respondent's objections and relator's answer. Cause remanded to the Board of Professional Conduct for consideration of mitigation evidence only. The interim default suspension imposed against respondent on November 22, 2019, shall remain in place while this matter is pending before the board. Proceedings before this court in this case are stayed until further order of this court.
