2019-0531. Defender Sec. Co. v. McClain, Slip Opinion No. 2020-Ohio-4594.

Franklin App. No. 18AP-238, 2019-Ohio-725. Judgment reversed and cause remanded. Tax commissioner ordered to issue refunds for 2011, 2012, and 2013 in the amounts set forth in the refund claim, plus the amount of any interest that may be provided by statute.

2018-0901. State v. Hundley.

Mahoning C.P. No. 2015 CR 1132. On appellant's motion for stay of execution. Motion granted. The stay shall remain in effect until exhaustion of all state postconviction proceedings, including any appeals.

2019-1753. Spence v. Deavers.

In Mandamus. On notice of federal-court dismissal. The stay is lifted, and the case shall proceed before the court. Respondent may file a response to the complaint, if any, within 21 days.
