MOTION AND PROCEDURAL RULINGS

2019-1809. Avery v. Wooten.

Miscellaneous case. On relator's "motion to correct the court's unconstitutional entry." Motion denied.

2020-0423. Ohio State Bar Assn. v. Timberwolf Litigation & Research Servs., L.L.C.

On relator's motion to show cause and motion for sanctions. Respondent ordered to show cause by filing a written response with the clerk of this court within ten days why respondent should not be held in contempt and sanctions imposed.

2020-0995. Wisehart v. Wisehart.

Preble App. No. CA2020-07-011. On appellants' request for judicial notice. Request denied.

MISCELLANEOUS DISMISSALS

2019-1498. Rayco Mfg., Inc. v. Murphy, Rogers, Sloss & Gambel.

Cuyahoga App. No. 106714, 2018-Ohio-4782. On joint application for dismissal. Application granted. Cause dismissed.

2020-1069. Smith v. Buchanan.

Noble App. No. 19 NO 0468, 2020-Ohio-3886. Appellant has not filed a merit brief, due November 2, 2020, in compliance with the Rules of Practice of the Supreme

2019-1490. State ex rel. TS Trim Industries, Inc. v. Indus. Comm.

Franklin App. No. 17AP-448. Appellant shall file a brief within 40 days, and the parties shall otherwise proceed in accordance with S.Ct.Prac.R. 16.02 through 16.07. As provided in S.Ct.Prac.R. 16.07, this court may dismiss this case or take other action if the parties fail to timely file merit briefs.

Pursuant to R.C. 2710.06(B)(1), the court has been notified that the parties in the following cases have reached a settlement. The cases are returned to the regular docket under S.Ct.Prac.R. 19.01.

2019-0778. State ex rel. Glass v. Pinkney.
