Lorain App. No. 17CA011215, 2019-Ohio-586. On appellant's motion for leave to file reply brief under seal. Motion granted.

In Habeas Corpus. On petitioner's motion for default judgment. Motion denied as moot.

#### 2019-1623. State v. DeVore.

Ashland App. No. 19-COA-017, 2019-Ohio-4035. Sua sponte, the clerk of this court ordered to replace the existing notice of appeal with the notice of appeal for Ashland County Court of Appeals case No. 19-COA-017 and to transmit a copy to the clerk of the Ashland County Court of Appeals for filing.

# 2019-1655. Burns v. Shoop.

Ross App. No. 19CA3691. On appellant's memorandum in support of jurisdiction. This case originated in the court of appeals and therefore should proceed as an appeal of right pursuant to S.Ct.Prac.R. 5.01. It appears, however, that the decision being appealed is a magistrate's decision. Sua sponte, appellant therefore ordered to show cause within 14 days why the appeal should not be dismissed for lack of jurisdiction pursuant to R.C. 2505.02.

#### **2019-1815. Reister v. Gardner.**

Butler App. Nos. CA2019-01-010, CA2019-01-011, and CA2019-01-020, 2019-Ohio-4720. On motion for admission pro hac vice of Anthony M. Cillo. Motion granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days.

#### 2020-0058. State v. DeVore.

Ashland App. No. 19-COA-012, 2019-Ohio-4034. Sua sponte, appellee allowed 30 days to file a memorandum in response to jurisdiction.
