## MOTION AND PROCEDURAL RULINGS

### **2020-0788. Columbus City School Dist. Bd. of Edn. v. McClain.**

Board of Tax Appeals, No. 2018-649. Sua sponte, parties ordered to show cause within ten days why the decision of the Board of Tax Appeals should not be vacated and this cause remanded to the Board of Tax Appeals for a determination of exemption under Sub.S.B. No. 57 of the 134th General Assembly. Within ten days after the filing of a show-cause memorandum by one party, another party may file a response to that memorandum. No additional memoranda may be filed.

### **2020-1015. Columbus City School Dist. Bd. of Edn. v. McClain.**

Board of Tax Appeals, No. 2018-1184. Sua sponte, parties ordered to show cause within ten days why the decision of the Board of Tax Appeals should not be vacated and this cause remanded to the Board of Tax Appeals for a determination of exemption under Sub.S.B. No. 57 of the 134th General Assembly. Within ten days after the filing of a show-cause memorandum by one party, another party may file a response to that memorandum. No additional memoranda may be filed.
