2020-1372. State v. Poteet.

Columbiana App. No. 19 CO 0030, 2020-Ohio-4732. On appellant's second motion for stay of court of appeals' judgment. Motion denied.

2020-1069. Smith v. Buchanan.

Noble App. No. 19 NO 0468, 2020-Ohio-3886. Appellant has not filed a merit brief, due January 21, 2021, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence. Cause dismissed.
