The parties are to brief the issue as stated on page 2 of the court of appeals' July 7, 2021 entry: "According to the language in place prior to the April 12, 2021 amendment, does res judicata bar a parent's argument on appeal from a permanent custody determination that the juvenile court failed to abide by the 90-day timeframe set forth in R.C. 2151.353(B)(1) when the parent failed to raise the argument to the juvenile court and failed to appeal an underlying abuse, neglect or dependency disposition?" The conflict case is *In re L.S.*, 4th Dist. Ross No. 20CA3719, 2021-Ohio-5516. Sua sponte, cause consolidated with 2021-0822, *In re K.K.*, and briefing in case Nos. 2021-0822 and 2021-0857 consolidated.

2021-0864. Maple Hts. v. Netflix, Inc.

Certified Question of State Law, United States District Court, Northern District of Ohio, Eastern Division, No. 1:20-CV-01872. On review pursuant to S.Ct.Prac.R. 9.05, the court will answer the following questions: (1) "Are Netflix and Hulu video service providers under Ohio law?" and (2) "Can Maple Heights sue Netflix and Hulu to enforce Ohio's video service provider provisions?" Petitioners shall file their merit brief within 40 days, and the parties shall otherwise proceed in accordance with S.Ct.Prac.R. 16.02 through 16.04 and S.Ct.Prac.R. 9.07.
