Belmont App. No. 19 BE 0011, 2020-Ohio-4034. On application of dismissal of Antero Resources Corporation. Application granted. Appeal of Antero Resources Corporation dismissed. The case remains pending on the other appeals filed.

Montgomery App. No. 28737, 2020-Ohio-6954. Appellants have not filed a memorandum in support of jurisdiction, due February 16, 2021, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore have failed to prosecute this cause with the requisite diligence. Cause dismissed.
