## MERIT DECISIONS WITH OPINIONS

**2020-0349. *State ex rel. McDougald v. Sehlmeier*, Slip Opinion No. 2021-Ohio-666.**

In Mandamus. Writ denied. Relator's motion requesting that this court allow him to use affidavit and public-records request attached to writ of mandamus as evidence granted. Relator's requests for statutory damages and court costs denied.

Cuyahoga App. Nos. 108767 and 103714, 2020-Ohio-4216. On appellants' motion for extension of time for certification and transmission of the record. Time for filing the record extended to March 24, 2021.

Tuscarawas App. No. 2019 AP 06 0019, 2020-Ohio-3250. Appellant has not filed a memorandum in support of jurisdiction, due March 4, 2021, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence. Cause dismissed.
