- $\{\P6\}$ 2) Plaintiff has suffered damages in the amount of \$41.94, plus the \$25.00 filing fee, which may be reimbursed as compensable damages pursuant to the holding in *Bailey v. Ohio Department of Rehabilitation and Correction* (1990), 62 Ohio Misc. 2d 19.
