- $\{\P 1\}$  THE COURT FINDS THAT:
- {¶2} 1) On June 7, 2002, plaintiff, Frederick Futrell, filed a complaint against defendant, Department of Rehabilitation and Correction, alleging his cassette tapes and cigarettes were lost while under the control of defendant's personnel. Plaintiff seeks damages in the amount of \$77.11 for property loss, plus \$25.00 for filing fee reimbursement. Plaintiff submitted the filing fee on July 25, 2002;
- $\{\P 3\}$  2) On September 24, 2002, defendant filed an investigation report admitting liability and acknowledging plaintiff suffered damages in the amount of \$102.11;
  - $\{\P4\}$  3) Plaintiff filed a response.
  - $\{\P5\}$  THE COURT CONCLUDES THAT:

- $\{\P6\}$  1) I find, by a preponderance of the evidence, negligence by defendant has been shown. Baisden v. Southern Ohio Correctional Facility (1977), 76-0617-AD; Stewart v. Ohio National Guard (1979), 78-0342-AD;
- $\{\P7\}$  2) Plaintiff has suffered damages in the amount of \$77.11, plus the \$25.00 filing fee, which may be reimbursed as compensable damages pursuant to the holding in *Bailey v. Ohio Department of Rehabilitation and Correction* (1990), 62 Ohio Misc. 2d 19.
- $\{\P 8\}$  Having considered all the evidence in the claim file and adopting the memorandum decision concurrently herewith;
  - $\{\P9\}$  IT IS ORDERED THAT:
- $\{\P 10\}$  1) Plaintiff's claim is GRANTED and judgment is rendered in favor of the plaintiff;
- $\{\P11\}$  2) Defendant (Department of Rehabilitation and Correction) pay plaintiff (Frederick Futrell) \$102.11 and such interest as is allowed by law;
  - $\{\P12\}$  3) Court costs are assessed against defendant.
