- {¶8} 7) On December 4, 2002, plaintiff filed a motion to stay proceedings. Plaintiff informs the court he has been moved from defendant to Southern Ohio Correctional Facility. He wishes to stay proceedings in this case until February 1, 2003;
- $\{\P 9\}$ 8) On December 4, 2002, plaintiff filed a reply to motion in opposition to plaintiff's motion for partial summary judgment;
 - {¶10} 9) On March 28, 2003, plaintiff filed a voluntary dismissal.
 - {¶11} IT IS ORDERED THAT:
- $\{\P 12\}$ 1) All motions filed by plaintiff and defendant prior to the filing of the voluntary dismissal by plaintiff are MOOT;
 - {¶13} 2) Plaintiff's case is DISMISSED without prejudice;
 - {¶14} 3) Court costs are assessed against plaintiff.
