- {¶6} 2) Plaintiff has suffered damages in the amount of \$420.00, plus the \$25.00 filing fee, which may be reimbursed as compensable damages pursuant to the holding in *Bailey v. Ohio Department of Rehabilitation and Correction* (1990), 62 Ohio Misc. 2d 19.
 - {¶7} Having considered all the evidence in the claim file and adopting the

memorandum decision concurrently herewith;

- {¶8} IT IS ORDERED THAT:
- $\{\P 9\}$ 1) Plaintiff's claim is GRANTED and judgment is rendered in favor of the plaintiff;
- {¶10} 2) Defendant (Miami University) pay plaintiff (Nicole M. Ross) \$445.00 and such interest as is allowed by law;
