THE COURT FINDS THAT:

{¶ 1} On September 3, 2004, plaintiff, Archie L. Thompson, filed a complaint against defendant, Ohio Veterans Home (OVHA), alleging he suffered personal injury as a result of negligence on the part of OVHA staff. Plaintiff seeks damages in the amount of \$615.92, for medical treatment expenses. The filing fee was submitted with the complaint;

{¶ 2} On November 5, 2004, defendant filed an investigation report admitting responsibility for plaintiff's medical bills and acknowledging plaintiff suffered damages in the amount of \$615.92, plus filing fee reimbursement.

THE COURT CONCLUDES THAT:

{¶ 3} I find, by a preponderance of the evidence, liability by defendant has been shown. *Baisden v. Southern Ohio Correctional Facility* (1977), 76-0617-AD; *Stewart v. Ohio National Guard* (1979), 78-0342-AD;

{¶ 4} Plaintiff has suffered damages in the amount of \$615.92, plus the \$25.00 filing fee, which may be reimbursed as compensable

damages pursuant to the holding in *Bailey v. Ohio Department of Rehabilitation and Correction* (1990), 62 Ohio Misc. 2d 19.
