- {¶ 1} 1) On September 8, 2006, plaintiff, Lazaro Averhoff, filed a complaint against defendant, Ohio State Highway Patrol ("OSHP"), alleging he incurred automobile property damage as a proximate cause of negligent acts on the part of OSHP personnel.
