ORDER OF A THREE-  
COMMISSIONER PANEL

{¶1} THE COURT FINDS THAT

{¶2} 1) On September 26, 2006, the applicant filed a reparations application seeking reimbursement of expenses incurred with respect to a May 30, 2006 shooting incident;

{¶3} 2) On September 29, 2006, the Attorney General issued a Finding of Fact and Decision denying the claim pursuant to R.C. 2743.60(E) contending that the applicant was convicted of a felony within ten years of the criminally injurious conduct;

{¶4} 3) On November 3, 2006, the applicant filed a request for reconsideration;

{¶5} 4) On December 5, 2006, the Attorney General issued a Final Decision denying the claim once again;

{¶6} 5) On December 27, 2006, the applicant filed a notice of appeal to the December 5, 2006 Attorney General's Final Decision;

{¶7} 6) On June 29, 2007, the court issued an order rescheduling the matter for oral hearing to September 6, 2007 at 10:30 A.M.;

{¶8} 7) On September 6, 2007, a hearing was convened. At the beginning of the hearing, applicant's counsel withdrew his December 27, 2006 notice of appeal.

{¶9} IT IS THEREFORE ORDERED THAT

{¶10} 1) The applicant's September 6, 2007 oral notice to withdraw the December 27, 2006 appeal is hereby NOTED;

{¶11} 2) Costs are assumed by the court of claims victims of crime fund.
