ENFORCEMENT PROCEDURES

If you fail to comply with the educational requirements of Gov. Bar R. X and/or Gov. Jud. R. IV, the Commission will send you a notice of noncompliance. The notice will specify the nature of the noncompliance and state that unless you come into compliance or file evidence of compliance that is satisfactory to the Commission by the date set forth in the notice, the Commission will issue an order imposing a sanction against you. As a condition of acceptance of late compliance, you will be required to pay a late compliance fee that accompanies your report of compliance.

If you submit evidence by the date set forth in the notice that establishes timely compliance or late compliance, the Commission will withdraw the notice of noncompliance and advise you of this action.

If you do not come into compliance or file satisfactory evidence, the Commission will issue a sanction order against you, consistent with Commission regulation. (Gov. Bar R. X, Secs. 5 and 6 and CLE Reg. 503)

Please remember that sanctions ordered by the Commission are published in the *Ohio Official Reports* and the *Ohio State Bar Association Report*.
