**REQUEST FOR ADMISSION BY
UBE TRANSFER SCORE**

I hereby make application for admission to the practice of law in Ohio by UBE transfer score. In conformity with Rule I of the Supreme Court Rules for the Government of the Bar, I am submitting the following (check each item being submitted):

- (1) certificates of good standing from all jurisdictions in which I am admitted, dated no earlier than 60 days prior to submission of the application, **if applicable**;
- (2) an official transcript evidencing that I have earned a bachelor's degree;
- (3) an official transcript evidencing that I have earned a law degree from an ABA-approved law school; PDF transcripts must be sent directly from the school to transcripts@sc.ohio.gov;
- (4) an executed Affidavit of Applicant;
- (5) an Applicant's Character Questionnaire, single-sided;
- (6) original Acknowledgment of Complete Application form;
- (7) a fingerprint identification card;
- (8) two original, separately executed General Authorization and Release forms (7A);
- (9) one original NCBE Authorization and Release form (7D);
- (10) original Authorization to Release Medical Information (7B) and/or Authorization to Release Information (7C) (if I have answered "yes" to any applicable questions on my Character Questionnaire);
- (11) a non-refundable registration fee in the amount of \$750, by **certified check or money order** made payable to the Supreme Court of Ohio;
- (12) the Payment Confirmation Form from the National Conference of Bar Examiners ("NCBE") and if applicable, a non-refundable fee by **check** made payable to the NCBE, in the appropriate amount as indicated on the NCBE fee schedule;
- (13) if applicable, and admitted and in good standing, a complete Application for Certification to Practice Pending Admission with the appropriate supporting documents;
- (14) I have previously submitted an Application to Register as a Candidate and submitted items 2, 5-10, and 12. (Please note a new questionnaire and other applicable documents may be required if deemed necessary by the Office of Bar Admissions.)

I have read Rule I of the Supreme Court Rules for the Government of the Bar, which pertains to admission to the practice of law in Ohio and sets forth the procedures to which I am subject. I understand that before being approved, I must have earned a qualifying UBE score that meets or exceeds the minimum score required by the Board of Bar Examiners, and the qualifying UBE score was earned within five years of the date of the submission of this application, but no earlier than the February 2016 administration of the UBE. I also understand that I must successfully complete the Ohio Law Component prior to admission and that I must receive final character and fitness approval from the Board of Commissioners on Character and Fitness.
