THE JUDICIAL FAMILY NETWORK (JFN) offers educational programs and print and online resources to the spouses, partners, and families of judges. JFN helps address questions related to judicial family life:

My spouse is a judge, do I need to report gifts that I receive?

Our friend is running for public office, can I put her campaign sign in our yard?

How do we support our son when his friend's father is a defendant in my wife's court?

My husband worked in private practice until his election, how does his new pension program work?

Ohio's Judicial Family Network (JFN) was started by Mary Moyer, wife of the late Chief Justice Thomas Moyer. While campaigning with her husband, Mrs. Moyer met men and women across the state who shared the unique challenges of having a judge in the family. In 2000, Mrs. Moyer helped form a steering committee, which implemented a mission statement and programming which continues to support Ohio's judicial families to this day.

The Advisory Committee on the JFN provides information and education on topics of concern and importance to judicial households and their extended family members. The committee provides opportunities for spouses and partners of judges to meet and interact with one another to foster informal networks of support and communication. Among current areas of interest to judicial families are social media and online presence, trauma-informed care, home and travel security, ethics guidelines, judicial elections, and quality of life issues.

Support

When a judge is appointed or elected, he or she is not the only person affected by the professional change. The transition to public life can require adjustments for everyone in the family as each person adapts to living their private life in the public eye. JFN connects family members to resources and guidance from other judicial families that have navigated the same challenges. You do not walk alone.

Events

The JFN typically hosts programs twice a year in conjunction with "New Judge Orientation." Additionally, quarterly Zoom programs are offered on a wide array of topics. As of December 2021, CLE will be offered at programs where applicable.

Starting Out

JFN programs will put you in touch with the human resources professionals to help guide you through changes to your health insurance coverage, pension options and other details of public employment. Additionally, the network offers step—by step insight about swearing-in activities.

Security

JFN can help you identify practical measures you can take to protect your family's safety and privacy away from the courthouse.

Online Presence

Can "liking" a post or tweeting a news article cause problems for the judge in your family? The consequences of Internet security for public officials and their families have never been more dire or easy to stumble into. Learn how to understand your digital footprint, smart phone technology, location applications, RFID's, doxing and commonly and uncommonly used social networking sites as well as ways to protect yourself and family members.
