OHIO VETERANS OF RECENT WARS TO GET BONUSES

Veterans are eligible to receive \$100 for each month of service in any of the three wars, up to \$1,000. Those who served elsewhere could get \$50 monthly, up to \$500, while family members of veterans who died during the recent conflicts are eligible for a payment up to \$6,500.

UC-DEVELOPED PROGRAM IS CHANGING APPROACHES TO SUPERVISING CRIMINAL OFFENDERS

A program developed by University of Cincinnati criminal justice researchers strives to strengthen the working relationship between probation/parole officers and offenders to help offenders stay on track toward building a life away from crime. The program, called "Effective Practices for Community Supervision Training" (EPICS), creates an action plan that addresses the criminal thought behaviors of higher-risk offenders. [More...](#)

STATE-PRISON FAIR OFFERS SOON-TO-BE-RELEASED INMATES RESOURCES FOR LIFE

Those in charge of running the Ohio State Penitentiary here want the facility to not only be about punishment and incarceration but also rehabilitation—especially for those about to be released back into society. The prison on Coitsville-Hubbard Road (state Route 616) houses 534 inmates from across the state in a facility with 504 cells and a prison camp with dormitory-like open sleeping quarters for low-level offenders. JUVENILES CAN SEAL RECORDS ON SATURDAY

Summit County Juvenile Court Judge Linda Tucci Teodosio is offering to seal juvenile traffic and nonviolent criminal records for free Saturday.

The program, dubbed "Operation Fresh Start," is open to anyone with a juvenile record in the county system who wants to wipe the slate clean.

The offer will be part of the first Summit for Kids family expo in downtown Akron. To encourage people to participate, Teodosio is waiving the usual \$50 filing fee. "We hope it's a good turnout and a good experience," the judge said. "And it's a nice way for people to get the work done without paying the fee. Boy, in this economy, \$50 is money that could put food on the table or put gas in the car."

NATIONAL INSTITUTE OF MENTAL HEALTH TO FUND RESEARCH ON THE REDUCTION AND PREVENTION OF SUICIDALITY

Deadline: September 8, 2010

The National Institute of Mental Health (NIMH), National Institute on Alcohol Abuse and Alcoholism (NIAAA), and the National Institute on Drug Abuse (NIDA) will fund research that will reduce the burden of suicidality (deaths, attempts, and ideation). Funding is intended to intensify investigator-initiated research on the topic, attract new investigators to the field, and increase interdisciplinary approaches to developing effective strategies to reduce suicidality. Mental disorders, along with alcohol use disorders (AUDs) and substance use disorders (SUDs), are of particular interest as they pertain to risk and protective factors and treatment efficacy and effectiveness for suicidality. Eligible applicants include public and private universities, nonprofits, for-profits, and state governments. The number and amount of grants to be awarded are contingent upon the availability of funds and the submission of a sufficient number of meritorious applications.
