## MENTAL HEALTH GROUP IN CLEVELAND TRIES TO BREAK DOWN BARRIERS IN BLACK, HISPANIC COMMUNITIES

Black and Hispanic communities historically have been more disconnected from the medical profession because of differing cultural attitudes, distrust, language barriers and limited resources, among other factors. The two groups also tend to consider mental illness as a sign of weakness, which might prompt some to forgo medical treatment. In an effort to de-stigmatize mental illness within the black and Hispanic communities, the National Alliance on Mental Illness Greater Cleveland has launched a workshop series designed to educate individuals and their families about mental health conditions and their symptoms. ## HOCKING COUNTY SHERIFF'S OFFICE AND DEA HEADS FIRST-EVER NATIONWIDE PRESCRIPTION DRUG TAKE-BACK DAY

Sheriff Lanny E. North and the U.S. Drug Enforcement Administration (DEA) announced today a nationwide prescription drug "Take-Back" initiative that seeks to prevent increased pill abuse and theft. DEA will be collecting potentially dangerous expired, unused, and unwanted prescription drugs for destruction. The prescription drug turn in will be held at the Hocking County Sheriff's Office located at 25 East Second Street on Saturday, September 25<sup>th</sup> from 10 a.m. to 2 p.m. The service is free and anonymous, no questions asked. You will be able to drive through the parking lot to drop of your old or un-used prescriptions.

### APPLICATION DEADLINE: 4 P.M. WEDNESDAY, SEPT. 15, 2010

Ohio Attorney General Richard Cordray announces a Request for Proposals (RFP) for the Community Small Grant Program, which will support nonprofit (501c3) organizations located in Ohio. Grants from \$2,000 to \$10,000 will be awarded for innovative projects that address local needs related to youth and families, the elderly, people with disabilities and others. These funds have been used in the past for a variety of projects, such as community holiday meals for families who are homeless, adult day services for senior citizens, summer camping and mentoring programs for youth, and outdoor rehabilitation programs for people with disabilities. The project period is for 12 months, and begins November 2010. A total of \$200,000 is being made available for this funding round. Funds are intended for specific projects rather than ongoing operational costs and must not supplant current project funds. Complete applications that include the cover sheet, brief program description, budget and budget narrative in the space provided must be submitted online at AGOGrants@OhioAttorneyGeneral.gov.
