R.C. 2323.311(B)(4) references Ohio Administrative Code 120-1-03, which sets out a standard of indigency by the Ohio Public Defender for appointment of counsel and also incorporates the federal poverty guidelines for consideration by the court. While the standards of indigency are for appointment of counsel in a criminal case, the same economic factors also are helpful for consideration when imposing a fine or other financial sanction.

For these offenses, a jail sentence may not be directly imposed, but to enforce the community service assignment, the defendant may be charged with indirect criminal contempt of court in accordance with R.C. 2705.02 et. seq. for failure to complete community service. This is a separate charge, however, and the defendant would be entitled to counsel and appointed counsel, if indigent.
