### **Ohio Legal Research Guide (KFO 75 P88)**

Comprehensive reference work includes a chapter on major Ohio treatises, practice books and newsletters arranged by subject matter.

### **A Select, Annotated Bibliography of Ohio Practice Materials**

*Ohio Northern University Law Review* 17, No.2 (1990): 265-301

Divided into three subject categories (primary authorities, finding tools and secondary authorities), this bibliography includes general comments on the reliability of the practice materials and how to use them.

### **State Practice Materials (REF KF 1 S73)**

Annotated bibliographies of basic legal practice tools for each state and the District of Columbia. Includes primary and secondary authorities, such as cases, statutes, law reviews and treatises. Covers print and electronic resources, with short annotations describing each resource. The chapter on Ohio is divided into general publications, periodicals, CD-ROM sources, Ohio-related legal resources on the Internet, subject-oriented practice materials and an appendix of publishers of Ohio legal materials.
