ADMINISTRATIVE ORDER

This matter came on for consideration this 5th day of August, 2021 to supersede the Court's prior Administrative Order of July 6, 2021 journalized at Vol. 142, Pg. 353.

The Judges of the Cuyahoga County Court of Common Pleas, Juvenile Division, make the following findings of fact:


1. On July 31, 2021, the Centers for Disease Control and Prevention ("CDC") identified Ohio and Cuyahoga County as an area of "substantial transmission." Recent evidence suggests that the Delta variant of COVID-19 is highly transmissible. Further studies show that while the vaccine is effective and can reduce the risk of severe COVID-19 symptoms, even those who are vaccinated can spread the highly contagious Delta variant.
2. Considering this, the CDC and Cuyahoga County Board of Health updated their guidance, recommending that those in areas of substantial transmission, including those who are fully vaccinated, wear a face covering in public indoor settings.

THEREFORE, IT IS HEREBY ORDERED:

1. Beginning Thursday, August 5, 2021, all individuals, including Court judicial officers and personnel, must wear a face covering/mask that covers both their nose and mouth while they are in the courthouse.
2. All individuals, including Court judicial officers and personnel, will be subject to temperature screening and may be excluded from admission based upon the results of such screening.
3. All other orders in the June 25, 2020 Administrative Order journalized at Vol. 142, Pg. 306 and the June 12, 2020 Administrative Order journalized at Vol. 142, Pg. 305 that have not been specifically modified previously and not superseded or modified herein remain in full force and effect.
4. This Order shall be served on the Supreme Court of Ohio, Ohio Judicial Conference, Cuyahoga County Clerk of Courts, Cleveland Metropolitan Bar Association, Cuyahoga County Prosecutor's Office, Cuyahoga County Public Defender's Office, Cuyahoga County Criminal Defense Lawyer's Association, Cuyahoga County Sheriff, Cuyahoga County Board of Health, Cuyahoga County Executive, Cuyahoga County Council, the website of this Court, and distributed to the media.
