DUE TO COVID-19 PANDEMIC :

This Court issues this General Order in response to the recent outbreak of Coronavirus Disease 2019 (COVID-19) and related deaths in Trumbull County Ohio and throughout the State of Ohio and hereby extends the General Order 20-01 issued by this Court on March 13, 2020, unless modified herein.

WHEREAS, on March 9, 2020, the Governor of the State of Ohio, Michael DeWine, issued Executive Order 2020-01D and declared a State of Emergency which has been extended to May 1, 2020. The Director of the Ohio Department of Health, Dr. Amy Acton, also extended her Director's Stay at Home Order issued March 22<sup>nd</sup>, 2020 through 11:59 p.m. on May 1<sup>st</sup>, 2020.

WHEREAS, on March 11, 2020, the World Health Organization publicly characterized COVID-19 as a global "pandemic" requiring "urgent and aggressive action" to control the spread of COVID-19;

WHEREAS, on March 13, 2020, the President of the United States declared a National Emergency;

WHEREAS, this Court, in order to mitigate the spread of COVID-19 and comply with orders issued by the State of Ohio given the outbreak of cases of COVID-19 and deaths as a result in this County and the severity of risk posed to the public, and given the Centers for Disease Control and Prevention mandate, the Governor, the Director of the Ohio Department of Health orders, and President's declarations and orders, it is hereby ORDERED that:

(1) All civil domestic relations and juvenile matters including specialized dockets currently scheduled for hearings set before any Judge or Magistrate of this Court including any associated deadlines are hereby continued and shall be rescheduled pending further Order of the Court.

(2) All juvenile delinquency cases, juvenile traffic cases currently scheduled to be heard before any Judge or Magistrate of this Court, including any associated deadlines are hereby continued and shall be rescheduled pending further notice.

(3) The time period of the continuances implemented by this General Order will be pursuant to Am. Sub. H.B. 197 signed into law on March 27, 2020 by the Governor of the

The public is encouraged to continue utilizing court services while following all applicable public health guidelines, the Governor's order and Dr. Amy Acton's Order to prevent the spread of COVID-19.
