5. By submitting this application, **I acknowledge** that, if I am registered as a military legal assistance attorney pursuant to Gov. Bar R. V, Section 7:

- a. I shall be authorized to represent military personnel in enlisted grades E-1 through E-4 and their dependents who are eligible for legal assistance under 10 U.S.C. §1044 in civil judicial and administrative proceedings before Ohio tribunals while I am employed, serving, or assigned within Ohio, to the extent such representation is permitted by the commanding officer, supervisory staff judge advocate, or chief legal officer of the military installation;
- b. I shall be subject to the limitations and restrictions of 10 U.S.C. §1044 and the regulations of my military service and shall be limited to the military clients' personal civil matters;
- c. I shall not demand or receive any compensation from military clients other than the usual military pay to which I am entitled;
- d. I shall, in all pleadings, cite Gov. Bar R. VI, Section 7, and include the name, complete address, and telephone number of the military legal office representing the military client and the name, grade, branch of the armed forces, and the military legal assistance registration number;
- e. I shall not practice before any Ohio tribunal, unless granted permission to appear *pro hac vice* in accordance with Gov. Bar R. XII, except for my own behalf and military clients eligible for legal assistance under 10 U.S.C. §1044 and Gov. Bar R. VI, Section 7;
- f. I shall not offer to provide legal services in Ohio to any person other than as authorized by my military service and Gov. Bar R. VI, Section 7;
- g. I shall not render legal services for any person in Ohio other than as authorized by my military service and Gov. Bar R. VI, Section 7;
- h. I shall not hold myself out as authorized to provide legal services in Ohio to any person other than as authorized by my military service and Gov. Bar R. VI, Section 7;
- i. I shall be subject to all rules and requirements governing the practice of law in Ohio, including the Ohio Rules of Professional Conduct and Gov. Bar R. X ("Continuing Legal Education"), except that I shall not be required to pay the registration fees of Gov. Bar R. VI, Section 2; and
- j. I shall report promptly to the Registration and Continuing Legal Education (CLE) Section any changes in my employment, service, or assignment; any change in my licensure status; and the imposition of any disciplinary sanction in any United States jurisdiction other than Ohio where I have been admitted to the practice of law.

6. By submitting this application, **I further acknowledge** that, if I am registered as a military legal assistance attorney, my limited authority to practice law under Gov. Bar R. VI, Section 7, **shall automatically terminate** upon the occurrence of any of the following:

- a. I am no longer employed, serving, or assigned to the military installation in Ohio from which the affidavit required by Gov. Bar R. VI, Section 7(A)(3), was filed;
- b. I am admitted to the practice of law in Ohio pursuant to Gov. Bar R. I;
- c. I cease to maintain active status in at least one United States jurisdiction other than Ohio;
- d. I fail to maintain current good standing in any United States jurisdiction other than Ohio in which I am admitted to the practice of law;
- e. I am suspended or disbarred for disciplinary reasons in any United States jurisdiction other than Ohio or by any federal court or agency in which I have been admitted to the practice of law; and
- f. I fail to comply with any provision of Gov. Bar R. VI, Section 7.
