## <u>Attorneys who completed their hours for the 2023-2024 period between January 1, 2025 –</u> <u>March 31, 2025</u>

If you did not complete your CLE requirements by December 31, 2024, you can come into compliance and avoid sanction by doing the following: (1) taking sufficient credit hours to **cure all credit hour deficiencies on or before 11:59 pm ET on March 31, 2025,** (2) submitting an online Late Compliance Request through the Attorney Services Portal on or before 11:59 pm ET on April 30, 2025, and (3) paying the applicable late compliance fee by credit card or ACH(checking account) on the portal upon email notification from the Office of Attorney Services by the due date contained in the email. Failure to pay by the due date will result in the rejection of the late compliance request.

To submit a request for late compliance, please be sure to complete all of the following:

- *Check your 2023-2024 transcript.* Confirm the number and type of hours you need to complete to come into compliance. It is not uncommon for sponsors to report hours for the 2023-2024 after the notice of apparent noncompliance is mailed thereby reducing or even removing your deficiency.
- *Complete all hours* necessary to remove your 2023-2024 deficiency.
- *Confirm* those hours are on your 2025-2026 transcript. These hours can be reported by the sponsor or you can add the hours yourself following these <u>instructions</u>.
