Increasing the VALUE, VIRTUE, and VOICE of PROFESSIONALISM

Objective

The purpose of the Lawyer to Lawyer Mentoring Program is to elevate the competence, professionalism, and success of Ohio lawyers through positive mentoring relationships. Mentoring creates an opportunity for an experienced lawyer to provide professional guidance and share practical knowledge and skills with a new lawyer during the critical transition from law student to legal practitioner.

Specifically, the mentoring relationship should:

- Foster the development and increase the knowledge of practical skills and legal customs for the new lawyer
- Create a sense of pride and integrity in the legal profession
- Promote collegial relationships among legal professionals and involvement in the organized bar
- Improve legal ability and professional judgment
- Encourage the use of best practices and highest ideals in the practice of law.

How it Works

Mentees and mentors select activities and topics from the mentoring curriculum to create a personalized mentoring plan, which guides their meetings throughout the course of a one-year mentoring term.

Mentoring pairs must meet at least six times for a total of nine hours, minimum.

CLE Credit

Mentees who successfully conclude the mentoring program will satisfy their New Lawyers Training requirement, provided they also take three hours of instruction in professionalism, law office management, and client fund management. Upon completion, mentors receive 12 hours of CLE credit, including 2.5 hours of professional conduct credit.

Cost

There is no cost to mentees or mentors to participate.

To Participate

To participate, a Mentee Application for the Lawyer to Lawyer Mentoring Program must be completed within 60 days of the new lawyer's swearingin ceremony.

A new lawyer may nominate a mentor from a pre-approved mentor list on the Court's website or ask an experienced lawyer who meets the program's eligibility requirements to submit a mentor application along with the new lawyer's application.

Experienced lawyers who wish to become a mentor should complete a Mentor Application.

Proven Results

New lawyers found great benefit from the Lawyer to Lawyer Mentoring Program. A survey of mentees at the end of a recent program's term found:

- 99% said they would recommend the program to other new lawyers
- 98% said they are better equipped to deal with ethical and professionalism considerations in their daily practice
- 97% said they learned about legal customs
- 97% said they are better prepared for the practice of law
- 93% said they have more practical knowledge about the practice of law
- 88% said they built collegial relationships with other members of the bar.



The swallow as a symbol for mentoring arises from the writings of Homer, where the word "mentor" has its roots. In The Odyssey, Athena, the Greek goddess of wisdom, assumes the form and voice of the nobleman Mentor to advise those she wishes to help. In Book 22, again as Mentor, she takes the form of a swallow to assist Odysseus in battle.
