# WORKSHEET G INTRODUCTION TO CAREER PATHS AND SETTING CAREER OBJECTIVES

Worksheet G is intended to facilitate discussion about different career paths and practice settings for lawyers, resources for exploring career options, and setting and achieving your mentee's long-term career objectives.

\* \* \*

- Discuss different types of law practice, including, but not limited to: government or public office, private practice (large firm vs. small firm vs. solo practice), corporate, environmental, the judiciary, non-traditional legal positions, and Legal Aid. Discuss your experiences in different practice settings with your mentee. Consider inviting another experienced lawyer to discuss their experiences in different practice settings with you and your mentee.
- Share your career path with your mentee. Discuss the long-term goals you had as a new lawyer, how your goals changed over time, any successes and failures you experienced, and what you might have done differently.
- If you specialize in an area of practice, share with your mentee how you acquired the expertise in that area, why you chose that concentration, and how to secure a job in your practice concentration.
- Describe to your mentee your typical day with respect to things such as court appearances, trial work, research and writing, client contact, discovery, mediation/dispute resolution, hours/vacation/benefits/quality of life, etc. Share what you enjoy most and least about your practice area. What or who was most instrumental in your developing practice expertise? What has been your greatest achievement?
- Discuss your mentee's career objectives. If your mentee does not have clear objectives, help your mentee create a five-year plan that includes their career objectives and strategies for meeting them. If your mentee is not in the type of practice they would like to be in long-term, you can introduce your mentee to lawyers in the field your mentee would like to explore.
- Review your mentee's resume. Suggest activities, professional development, and personal development opportunities to strengthen your mentee's resume and help them distinguish themselves from others.
- Discuss networking opportunities that coincide with your mentee's objectives and how bar association and other types of community involvement can enhance career exploration and opportunities.
