Approval of the Minutes: The minutes of the December 8th meeting were approved after a correction noting that Velta Moisio was in attendance.

Subcommittee Reports on Initial Recommendations

The subcommittee chairs reported on the recommendations that their respective subcommittees have drafted. A complete list of these recommendations was included in the meeting materials. Below is a highlight of the subcommittees' recommendations.

Appellate Subcommittee (Eaton)

- Develop standard briefing templates
- Offer training and guidance for lower court clerks on what records need to be transmitted to courts of appeals
- Explore more cost-effective ways to provide a trial transcript
- Record oral arguments
- Continue remote oral arguments

Civil Jury Trials, Civil & DR (English)

- Amend Civil Rule 43 to allow witness testimony to be taken remotely
- Amend Civil Rule 38 and 39 to allow for remote civil jury trials
- Recommend the Supreme Court to purchase a supply of mobile devices for jurors to use

Court Operations (Hein)

- Implement basic minimum standards for accessibility to courts
- Develop best practice to implement technology recommendations
- Change the way the Supreme Court technology grants are awarded to incentivize the use of remote technology

Criminal & Jury Trials (Peeples)

- Confrontation Clause allows for the use of technology in criminal cases
- Develop procedures to ensure juror participation
- Establish processes for juror deliberation/sequestering
- Request that grants be tied to participation with minimum standards

Juvenile & Probate (Walther)

- Continue conducting hybrid hearings where appropriate
- Create general definitions of remote instead of revising individual code sections
- Allow for the acceptance of electronic signature
- Allow for personal service to be made in guardianship cases
- Use physical drop boxes where electronic filing is not available to allow for less personal contact during pandemic
- Educate local attorneys on how to use remote technology

Next Steps: Subcommittees need to finalize their recommendations by the next meeting.
