DEFENDANT AMERICAN BANKERS INSURANCE COMPANY OF FLORIDA'S MOTION FOR SUMMARY JUDGMENT 10/31/2025, IS GRANTED. DEFENDANTS' MOTION FOR SUMMARY JUDGMENT IS GRANTED. BASED UPON THE UNREFUTED EVIDENCE AND LEGAL ARGUMENTS PRESENTED BY DEFENDANTS, THERE REMAIN NO GENUINE ISSUES OF MATERIAL FACT THAT PLAINTIFF RAKHSHANDA TALIB HAS ENGAGED IN VEXATIOUS CONDUCT IN VIOLATION OF R.C. 2323.52.
