

REQUEST FOR ACCESS TO OHLEG eDISPOSITION PORTAL INSTRUCTIONS

The eDisposition portal within OHLEG is designed to allow court personnel, clerks of court, and other authorized users access to criminal record information maintained by BCI. Users will be able to view, modify, and delete criminal records submitted for their Court. Additionally, users will be able to view arrests in their county for which no disposition is on file at BCI and manually update the disposition.

This form is intended to provide instructions to help users gain access to the new OHLEG eDisposition Portal. This document will explain scenarios for agencies with OHLEG access, those needing to add users to their existing OHLEG Roster, and those agencies needing to obtain OHLEG access.

Agencies without existing OHLEG access:


Agency Administrators should complete the attached forms and submit them to OHLEGSupport@ohioago.gov After receiving your application, OHLEG staff will assist you with the new agency onboarding process.

The forms that are to be completed are:

- *The Agency Request for eDisposition* This form should be completed in its entirety by the administrator.
- The OHLEG Access Designation Form This form should be completed by the Admin.
 This is to designate someone that will have OHLEG access and give them the right to
 manage the agencies Roster. The Agency Roster is a list of users that have access to
 OHLEG. The designee(s) will have the right to suspend or remove access for users who
 no longer need it either due to position change, extended leave or separation from the
 agency.
- The Request for OHLEG Access Form This form should be completed by everyone that will need an OHLEG account to be able to access the e-Disposition portal. The request forms should be approved by the Admin.

When the forms are completed and submitted, the OHLEG staff will process them as efficiently as possible, and they will email confirmation when completed. Each user who applied for OHLEG access will receive a password separately.





Agencies with existing OHLEG access:


Agency Administrators should complete the attached eDisposition Request Form only and submit it to OHLEGSupport@ohioago.gov. Each current OHLEG user that requires eDisposition access should be listed.

If one of your staff who needs eDisposition access does not currently have OHLEG access, that user will need to contact their OHLEG Agency Coordinator (OAC) to fill out the OHLEG Online Account Application (OOAA) via the OHLEG portal.

REQUEST FOR ACCESS TO OHLEG eDISPOSITION PORTAL form FAQs

Question: If I am a Clerk of Court, can I apply for access directly or do I need to apply in conjunction with my local court?

Answer: You can apply directly. When completing the application, identify the court whose records you maintain and their ORI. Records submitted to BCI on behalf of a local court are associated with the local court's ORI. You will only be able to view, modify, and delete records associated with your local court's ORI.

Question: Whose email addresses should be listed to receive logs and reports from this system?

Answer: Each time a record is updated through this portal you will receive a report identifying whether the changes were successful. Records are only indexed once per day, so submission logs are typically sent the day after changes are made. Multiple email addresses can be listed, but we recommend you provide a shared email address to ensure reports can be accessed even when staff are on vacation, sick, or are otherwise unavailable.

Question: Which law enforcements agencies do I need to include and why do I have to list them?

Answer: Records submitted to BCI by local law enforcement do not identify the court in which charges may be filed. However, the records do identify the arresting agency. To ensure you see relevant arrest records, you will need to identify agencies whose cases may be filed in your jurisdiction. We recognize that this is an imperfect solution as some agencies generate cases in numerous jurisdiction (i.e. the Ohio State Highway Patrol, Ohio Department of Natural Resources, etc.). In the future, we hope to deploy a more effective solution.

I am requesting access as a representative of my employing criminal justice agency. I acknowledge that the information and data on OHLEG is confidential and sensitive, and I agree that I will utilize this information exclusively for the official purposes of my agency in the administration of criminal justice. Access to OHLEG is a privilege subject to termination. Data accessed through OHLEG is continuously subject to limitations on use and dissemination and is not to be sold, transmitted, or disseminated to any unauthorized person. To protect the system from unauthorized use and to ensure that the system is functioning properly, individuals using this computer system are subject to having all of their activities monitored, recorded, and audited. Anyone using this system expressly consents to such monitoring and is advised that any evidence of possible abuse or criminal activity will be provided to appropriate officials. Unauthorized attempts to upload or change information, or otherwise cause damage to this service, are strictly prohibited. I acknowledge that any unauthorized access or misuse of the law enforcement information or data on this site is prohibited by Revised Code section 2913.04, and constitutes a fifth degree felony. I further acknowledge that any failure to abide by the conditions and restrictions in the user agreement and in the OHLEG Rules and Regulations will result in a loss of my privileges of access to this tool. OHLEG Administrative Access Designation Form for eDisposition Only Agency

Upon the appointment or election of new Chief Executive Officer (CEO), OHLEG requires a Designation Form be completed, signed by the CEO. The Designation Form is used to appoint specific administrative rights and oversight of the agency's OHLEG accounts. The CEO can assign an individual(s) to the role of OHLEG Agency Coordinator (OAC), or the CEO can choose to be the only user with admin rights. Once this form is completed and returned, the designee(s) will receive admin access accordingly.

This form should also be used anytime a CEO wants to change their administrative access including the appointment of a new OAC.

OHLEG Agency Coordinator Role Description:

The OAC is the OHLEG main point of contact for the agency. They will also be the individual responsible for training, removing a user from the agency's OHLEG Roster when necessary, and validating the roster every 90 days through the OHLEG Roster application.
