# OHIO ELDERCARING COORDINATION

A dispute resolution option for families in high conflict that turn to the court for decisions regarding the care and safety of their aging loved ones.

ELDERCARING COORDINATOR TRAINING: This 28-hour training meets the ACR/FLAFCC Guidelines for Eldercaring Coordination. The training program emphasizes experiential learning using demonstrations, practice and roleplays, with debrief and feedback to reinforce application of skills. Interactive experiences will make ethics and the aging process come alive as it pertains to eldercaring coordination.

**Who should attend?** As per the ACR/FLAFCC Guidelines for Eldercaring Coordination, an Eldercaring Coordinator shall be licensed or certified by a regulatory body of a jurisdiction, state or province, with at least a master's degree and all of the following:

- a. Completion of family mediation training certified or approved by the circuit, state or province or commensurate with the objectives established by the Association for Conflict Resolution; and
- Completion of elder mediation training certified or approved by the circuit, state or province or commensurate with the objectives established by the Association for Conflict Resolution; and
- c. Completion of eldercaring coordination training certified or approved by the circuit, state
  or province or commensurate with the objectives established by the Association for
  Conflict Resolution; and
- d. Extensive practical experience in a profession relating to high conflict within families.

This practical training focuses on the application of the eldercaring coordination process and builds upon the prior knowledge, skills, training and experience of participants. The training parameters and objectives establish eldercaring coordination as a unique interdisciplinary process. In order to enhance the professional practice and confidence of new eldercaring coordinators, this training provides an integrated experience focused on learning and applying eldercaring coordination skills and techniques throughout all of the phases of the process.

Upon completion of this training, participants will be able to explain all of the following: 1) overview of eldercaring coordination process, 2) legal context of the eldercaring coordination process; 3) orientation phase of the eldercaring coordination process; 4) capacity considerations and screening during eldercaring coordination; 5) the elder within the context of the eldercaring coordination process; 6) the engagement phase of the eldercaring coordination process; 7) high conflict family dynamics and the management phase of the eldercaring coordination process; 8) elder abuse, neglect, exploitation, substance abuse and family violence as it pertains to eldercaring coordination; 9) application phase of the eldercaring coordination process; 10) integration phase of the eldercaring coordination process; and 11) ethical considerations pertaining to eldercaring coordination.

**Sue Bronson, M.S., LCSW, Co-Chair of the Eldercaring Coordination Initiative**, is a trainer and mediator of family, elder, and workplace disputes in Milwaukee, WI since 1983. Sue has nearly 40 years' experience as a psychotherapist and mediator helping people engage in quality conversations. She teaches mediation at the University of Wisconsin - Milwaukee School of Continuing Education. Sue is the lead author of Self-Assessment Tool for Mediators translated into three languages.

Linda Fieldstone, M.Ed., Co-Chair of the Eldercaring Coordination Initiative, is former Supervisor of Family Court Services, servicing families in conflict for the 11th Judicial Circuit, Miami-Dade County, Florida, and was instrumental in the development of parenting coordination. Linda is past President of the Association of Family and Conciliation Courts and its Florida Chapter; Secretary of the AFCC Task Force on Parenting Coordination and Co-recorder for the Task Force to update standards; and on the Florida Supreme Court ADR Rules and Policy Committee.
