


## Prevalence of Parental Alcohol or Drug Abuse as an Identified Condition of Removal in the United States, 2000 to 2020


## Percent of Children with Terminated Parental Rights by Identified Condition of Removal in the United States, 2020

# Family Treatment Court Best Practice Standards Standard 8: Monitoring and Evaluation

#### **Provisions**









### Maintain Data Electronically

Standard 8, Provision A

The FTC uses an electronic database to store information about the services provided to children, parents, and family members and to monitor participants' performance in the FTC. The FTC team records information about participant demographic characteristics; dependency court actions and processes; child welfare indicators; substance use disorder (SUD) and mental health treatment; other parent or caregiver, child, family, and parenting needs and services; recovery and reunification support; criminal justice involvement; and children, parent, and family well-being. To the extent possible, data related to the long-term outcomes of child and family well-being following participation in the FTC are also collected.

# Engage in a Process of Continuous Quality Improvement

Standard 8, Provision B

The FTC promotes practices and supports an environment in which all partners collaborate to continuously improve processes and outcomes. Data entry occurs within 48 hours of each activity or event and is routinely monitored for quality assurance. Data summaries give the FTC operational team real-time information on participant, process, and outcome measures from which the FTC can engage in continuous quality improvement. Data summaries are also provided to the steering committee and oversight committee to assist in policy setting and sustainability efforts. The FTC engages in an annual evaluation of its policies, procedures, and outcomes and develops an action plan to address challenges, incorporate best practices, and improve outcomes.

### Evaluate Adherence to Best Practices

Standard 8, Provision C

The FTC adheres to best practice standards as defined by research on FTCs and in the related areas of child welfare; dependency court; the treatment court model; SUD and mental health treatment; children's developmental service and related health, educational, and social services for children, parents, and family well-being. The FTC uses a standardized approach to monitor provider outcomes and services as well as the quality of support programs, including their fidelity to evidence-based programs and practices.

### Use of Rigorous Evaluation Methods

Standard 8, Provision D

The FTC ensures evaluations are conducted using the most rigorous methodology available that is both feasible and appropriate to address the pertinent evaluation questions. Whenever feasible, comparison groups are used to increase the credibility of the evaluation results and interpretation of findings.

One of the most important issues to consider when choosing to engage in an evaluation is whether the report will provide recommendations that the FTC can use to enhance its adherence to best practices and improve its outcomes. As a community-based collaborative intervention, the FTC involves partner agencies in the formation of research questions and methods to access data.

### Long Term Outcomes - What is Success? E and 5 Rs

Equitable Outcomes in:	All outcomes should be disaggregated by race, ethnicity, gender, and other key demographic information
Recovery	<ul> <li>Parents access treatment more quickly</li> <li>stay in treatment longer</li> <li>decrease substance use</li> </ul>
Remain at Home	More children remain at home throughout program participation
Reunification	Children stay fewer days in foster care and reunify within 12 months at a higher rate
Repeat Maltreatment	Fewer children experience subsequent maltreatment
Re-entry	Fewer children re-enter foster case after reunification



# Data Dashboard

The FTC selects a set of critical data indicators that help the operational team and steering committee members monitor critical FTC operations such as referrals, admissions, completions, and terminations.\*

- Determine your audience
- Select Measures What outcomes are the most important? What needles are you trying move?
- Tell a Story Make sure visualizations are clear and intuitive
- Baselines and Targets What are we trying to achieve and compared to what?



#### HARNESSING THE POWER OF FAMILY TREATMENT COURTS: USING DATA AS A TOOL FOR CHANGE









#### INTRODUCTION

Family treatment court (FTC) is a juvenile or family court docket for cases of child abuse or neglect in which parental substance use and often co-occurring mental health disorders are contributing factors. FTC teams provide parents, children, and family members with timely and equitable access to comprehensive care, increased case management, and intensive judicial oversight. The goals are to ensure children have safe, nurturing, and permanent homes, avoiding out-of-home placement whenever possible; parents and family members receive services and supports to meet their individual needs; and parents achieve stable recovery from their substance use and mental health disorders. FTCs can secure funding for and create long-term sustainability of the necessary services and supports for the families they serve as well as all families in the systems they represent.

It is important to recognize the numerous meanings of "family" and the differing roles of family members. This series of briefs defines family as parents, children, nuclear family members, extended family members, and families of choice (unrelated by blood or marriage but whose members regard one another as family).

Integrating performance monitoring and evaluation as core program operations—both essential activities for determining whether the FTC team is achieving its desired results and overall mission—increases the team's ability to effectively meet the needs of families.

This brief... is part of a series focused on helping collaborative teams fund (*Brief 1*) and evaluate briefs combine existing collaborative practices to present an overview of pertinent strategies for FTC teams. The series is intended as three interrelated briefs but each resource can be viewed individually. Links to tools and resources are provided throughout the briefs for more in-depth information on each topic.
