#### **CUYAHOGA COUNTY JAIL MAY CHANGE POLICY ON PRESCRIPTION DRUGS**

Sean Levert's legacy could be that no other Cuyahoga County jail prisoner will die for being denied prescription medicine. The jail's administrator and a doctor who oversees medical care on Friday proposed a policy change so that new inmates taking benzodiazepines, a family of drugs including Xanax, get the medicines as soon as their prescriptions can be verified. #### **COURTS FOR VETERANS SPREADING ACROSS U.S.**

State criminal courts devoted to U.S. war veterans are emerging across the country, from New York to Oklahoma to California, as increasing numbers of soldiers returning from the wars in Iraq and Afghanistan are showing up as defendants with a special set of problems. State court judges are joining with local prosecutors, public defenders, U.S. Department of Veterans Affairs officials and local lawyer volunteers to create courts with veterans-only case proceedings, because they have seen a common thread of post-traumatic stress disorder (PTSD), substance abuse, head injuries and mental illness underlying the veterans' crimes. The dangerously out-of-date medical policies of the Cuyahoga County Jail are in desperate need of an overhaul – the sooner, the better. Yet Sheriff Gerald McFaul has done nothing since the shameful death last March of a frightened and confused Sean Levert, according to a story by Plain Dealer Reporter Peter Krouse. The troubled R&B singer obediently gave his anti-anxiety medicine, Xanax, to jail officials, as ordered, shortly after his arrival. It shouldn't take the death of a celebrity inmate to force the Cuyahoga County Jail to create a sensible medication policy that might save lives. Yet that's what happened. Nine months after R&B singer Sean Levert died in the jail from causes including his sudden withdrawal from Xanax, jail officials have written a proposal to move quickly to refill prescriptions for inmates on the anti-anxiety drug and

other medications in the Xanax family. The proposed policy also calls for weaning inmates from the powerful drug - hopefully under close supervision. [More...](#)

The OVW Transitional Housing Assistance Grants for Victims of Domestic Violence, Dating Violence, Stalking, or Sexual Assault Program (Transitional Housing Assistance Program) focuses on a holistic, victim-centered approach to provide transitional housing services that move individuals into permanent housing. Grants made under this grant program support programs that provide assistance to victims of domestic violence, dating violence, sexual assault, and stalking who are in need of transitional housing, short-term housing assistance, and related support services.

### CSAT TRAVEL AWARDS

The Center for Substance Abuse Treatment (CSAT) will sponsor up to 30 Travel Awards for substance abuse treatment practitioners to attend the 2009 CPDD meeting. **FREE IN-SERVICE TRAINING FOR ELEMENTARY SCHOOL PROFESSIONALS OFFERED BY THE OHIO DEPARTMENT OF EDUCATION**

The requirements for elementary professional staff members to take in-service child abuse detection training in Ohio was recently expanded by legislation, HB 276. In addition to child abuse detection, the four hours of in-service training now required must also cover the prevention of violence and substance abuse and the promotion of positive youth development.

All elementary school professionals are **required** to fulfill the expanded in-service training requirements by **March 30, 2009**, and every five years thereafter. New employees must complete the training within two years of commencing employment, and every five years thereafter.

To help educators meet the new requirements, the Ohio Department of Education (ODE) worked collaboratively with a host of organizations and interested parties to develop a Safety and Violence Prevention Curriculum. The Department is presenting a series of FREE train-the trainer sessions statewide to assist districts in conducting local programs. A list of upcoming training sessions, information on cost reimbursement and the curriculum itself appear on the ODE website at [www.ode.state.oh.us](http://www.ode.state.oh.us) (keyword: safety and violence prevention training). While designed as train-the trainer sessions, ODE invites all elementary through high school staff members to attend such training. ### POLICY FRAMEWORK TO STRENGTHEN COMMUNITY CORRECTIONS

During 2008, the Pew Public Safety Performance Project and a group of leading practitioners and researchers reviewed a wide range of strategies for improving community corrections and making the best use of taxpayers' investments in public safety. A [\*Policy Framework to Strengthen Community Corrections\*](#) is the result. This package of policy-level actions for state legislators, executives and courts is now posted on the [Pew Center on the States](#) website. The provisions in the Policy Framework will help corrections agencies implement "evidence-based practices" by providing fiscal incentives, clearing obstacles, enhancing their authority, and tracking their results. The individual sections will have impact if adopted alone; taken together, however, they offer policy makers a powerful opportunity to help reduce victimization and control corrections costs. Looking to the 2009 legislative sessions and beyond, the Pew Public Safety Performance Project will be working with state policy makers to tailor the framework to their state's individual circumstances.
