COURT'S OVI OFFENDER PROGRAM HAS FIRST GRADUATE

“Dave” has seemingly gotten his life turned right side up. The Butler County resident would go out every Friday night and drink, then wake up Saturdays in misery. “I had drank and had issues for 30 years. But where I was at this point, at this time, I was binge drinking on the weekends,” said the 49-year-old. “My health was bad and I have breathing problems, and alcohol doesn’t help that. I never would ask myself why I was doing this.” [More...](#)

OHIO LAWMAKERS WANT TO MANDATE PRESCRIPTION MONITORING BY DOCTORS

Even as prescription drug abuse reaches an all-time high, Ohio's doctors aren't using a statewide prescription monitoring database that allows them to check whether a patient is "pill shopping." The

powerful [Buckeye State Sheriffs' Association](#) wants that to change. The association, which has been working with the [Ohio State Board of Pharmacy](#) to write legislation with input from state lawmakers, plans to meet tomorrow] to discuss the proposed law. Their law – which they are still crafting – would require doctors, nurses, dentists and others with the power to prescribe medicine to consult the statewide database before prescribing narcotics for patients complaining of chronic pain. PRISONERS OF PAROLE

In 2004, Steven Alm, a state trial judge in Hawaii, was frustrated with the cases on his docket. Nearly half of the people appearing before him were convicted offenders with drug problems who had been sentenced to probation rather than prison and then repeatedly violated the terms of that probation by missing appointments or testing positive for drugs. SUPREME COURT DEBATES RIGHT TO COMMIT SEXUAL PREDATORS AFTER PRISON TERMS

A majority of Supreme Court justices seemed inclined Tuesday to accept that the federal government has the power to indefinitely hold prisoners who are deemed sexually dangerous, even if they have completed their sentences. Solicitor General [Elena Kagan](#) told the court that, when Congress passed a law authorizing civil commitments in such cases, it was doing "something pretty simple and very reasonable." But the U.S. Court of Appeals for the 4th Circuit said Congress exceeded its authority, because the power to authorize what is normally a state function cannot be found in the Constitution. GRANTS AVAILABLE FOR ADULT DRUG COURTS

Deadline: February 11, 2010

The Bureau of Justice Assistance (BJA) is accepting applications for Implementation, Single Jurisdiction Enhancement and Statewide Grants under the Adult Drug Court Discretionary Grant Program. **PURPOSE:** To establish or enhance Drug Courts and systems for nonviolent substance-abusing offenders. For the purposes of this solicitation, **the definition of "Adult Drug Court" may include Driving While Intoxicated (DWI)/Driving Under the Influence (DUI) Courts, Co-Occurring Drug and Mental Health Courts, Veterans' Treatment Courts, and Community Courts.** **WHO CAN APPLY:** For Implementation and Single Jurisdiction Enhancement Grants, applicants are limited to states, state and local courts, counties, units of local government, and federally-recognized Indian tribal governments; Indian tribal governments may apply directly or through other public or not-for-profit private entities. THE SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION (SAMHSA) IS ACCEPTING APPLICATIONS FOR MORE THAN \$29 MILLION IN GRANTS TO EXPAND SUBSTANCE ABUSE TREATMENT FOR JUVENILE DRUG COURTS

The purpose of this program is to expand and enhance substance abuse treatment services in courts using the Juvenile Drug Court model in order to provide alcohol and drug treatment, recovery support services and program coordination to juvenile defendants/defenders. It is expected that up to 27 grants will be awarded for up to three years. The average annual award amount for each grantee is expected to be up to \$325,000. **WHO CAN APPLY:** SAMHSA/CSAT is restricting eligibility to existing individual Juvenile Drug Courts or their Tribal/State or local governmental proxies who may apply on their behalf. **APPLICATION DUE DATE:** Applications must be received by February 23, 2010

The Office of Juvenile Justice and Delinquency Prevention (OJJDP) seeks information on initiatives that help states achieve or maintain the deinstitutionalization of status offenders (DSO). OHIO YOUTH ASSESSMENT SYSTEM TRAININGS

The Department of Youth Services is pleased to announce the completion of the Ohio Youth Assessment System. Over the past three years, DYS has partnered with University of Cincinnati (UC) to develop a risk, needs and responsivity assessment specific to Ohio's youth. With the help of the pilot counties and facilities UC was able to collect and analyze data in order to develop a system of assessments that expand as a youth moves deeper into the system. The OYAS is made up of five instruments (Diversion, Detention, Disposition, Residential and Reentry) which will assist juvenile justice professionals in making the best decisions for youth and creating a common language across systems.
