## NEWS

### **ADVISORY OPINION ISSUED ON ALTERNATIVE COMMUNITY CONTROL SANCTIONS**

The Board of Commissioners on Grievances and Discipline have recently issued an advisory opinion regarding whether it is proper for a judge who has sentenced an offender for a felony or a misdemeanor offense to grant the offender's request to replace a community control sanction of community service with a financial contribution to a charitable organization. The opinion found that such actions are not ethically proper and contravene several rule provisions found in the Code of Judicial Conduct. Since this opinion may impact alternatives offered by courts to those required to perform community service, a link to the [full opinion](#) is being provided here for review.

### **SANDUSKY COUNTY PRISONERS ATTEND RE-ENTRY FAIR**

The first ever re-entry fair in the county was aimed at current and past prisoners and their families and at connecting them with the assistance necessary to break out of a cyclical system that seems to encourage repeat offenders and career criminals. The inmates at the fair were supervised by Community Work program coordinator Jim Seaman, and got a chance to see the job resources available to all residents alongside former inmates and their families. ### **JUDGE SUPPORTS EFFORT FOR VETERANS COURT**

The effort to establish a veterans court in Youngstown is moving forward and could be operating by the end of the year. Judge Robert Milich is spear heading the effort to create a specialized court docket to assist veterans who enter the criminal justice system. A spokesperson for VA services in Cleveland is impressed by the local effort. "And I think if Youngstown is successful and, I have every reason to believe they will be, it really could be a model for the rest of the state," says Patricia Hall with Veterans Administration. A representative of the Ohio Supreme Court briefed the local group on what is needed to have a specialized docket for veterans approved by the state. [More...](#)

### **SENATOR WANTS TO CORRECT PRISONS**

On the heels of a report criticizing Ohio's probation structure and sentences for low-level offenders, a Cincinnati Republican said it's long past time for lawmakers to start reforming the state's prison system. "This is not an ideological issue," Sen. Bill Seitz said yesterday as he and others involved in Ohio's criminal-justice system were briefed on a new report by the Council of State Governments. "This is about two things: saving money and putting our resources to what works to reduce recidivism. What's not to like about that?" [More...](#)

Ohio's probation system is too fragmented and the state cycles too many low-risk offenders serving short sentences through the prison system, a report to be released Monday finds. The study also says offenders who commit minor drug and property crimes are often supervised for years, while inmates who pose a high risk to public safety are released from prison without supervision. #### **INMATE'S PAINFUL DEATH AVOIDABLE, FAMILY SAYS IN LAWSUIT**

There is little doubt that Eric L. Hughes died a horrible death. The question is: Whose fault was it? Hughes, 31, a seriously mentally ill prisoner from Franklin County, died July 10, 2009, after spending 24 hours in agony suffering from "toxic megacolon." That's a fancy medical term for radical, bloating constipation. It poisons the body, causes dehydration, triggers a rapid heart rate, violent vomiting and, sometimes, death. In a lawsuit filed this month in the Ohio Court of Claims, attorneys for the Hughes family say the Ohio Department of Rehabilitation and Correction is to blame for failing to provide him with lifesaving medical care in the days preceding his death. ### **NATIONAL INSTITUTE OF MENTAL HEALTH TO FUND RESEARCH ON THE REDUCTION AND PREVENTION OF SUICIDALITY**

**Deadline:** September 8, 2010

The National Institute of Mental Health (NIMH), National Institute on Alcohol Abuse and Alcoholism (NIAAA), and the National Institute on Drug Abuse (NIDA) will fund research that will reduce the burden of suicidality (deaths, attempts, and ideation). Funding is intended to intensify investigator-initiated research on the topic, attract new investigators to the field, and increase interdisciplinary approaches to developing effective strategies to reduce suicidality. Mental disorders, along with alcohol use disorders (AUDs) and substance use disorders (SUDs), are of particular interest as they pertain to risk and protective factors and treatment efficacy and effectiveness for suicidality. Eligible applicants include public and private universities, nonprofits, for-profits, and state governments. ### JUSTICE POLICE INSTITUTE (JPI) ADDRESSES YOUTH IN THE JUSTICE SYSTEM

Young people with a history of trauma and victimization are overrepresented in the criminal justice system, said The Justice Policy Institute (JPI) in its recently released study *Healing Invisible Wounds: Why Investing in Trauma-Informed Care for Children Makes Sense*. Traumatized youths, who represent between 75 and 93 percent of incarcerated youths, are more likely to develop psychiatric conditions and experience developmental delays and decreased cognitive abilities. Because jails and prisons often do not screen for trauma, they do not appropriately treat it and may even add to it, the study found. The report suggests several policy changes to allow the judicial system to recognize trauma in children better. JPI recommends improved trauma reporting and screening, improved trauma assessment, targeted prevention and intervention programs, and services and treatment for those who experience trauma. In addition, JPI recommends making a young person's exposure to trauma a consideration when deciding sentencing.

### NEW FIGURES FOR ED VISITS DUE TO MH & SUBSTANCE ABUSE CONDITIONS

A recent report by the Agency for Healthcare Research and Quality (AHRQ) showed that 1 out of every 8 adult hospital emergency department (ED) visits involved a mental health or substance abuse condition. Further, these ED visits were 2.5 times more likely to result in a hospital admission than ED visits for other health conditions. From these visits, Medicare and Medicaid paid for 50 percent of the mental health and substance abuse related conditions with private insurance covering approximately 25 percent. ### SAMHSA RELEASES SUPPORTIVE HOUSING TOOLKIT

After many years of development, the U.S. Substance Abuse and Mental Health Services Administration (SAMHSA) Center for Mental Health Services has finalized and posted a new toolkit on its website that affirms permanent supportive housing's status as an evidence-based practice. Permanent Supportive Housing is decent, safe, and affordable community-based housing that provides residents the rights of tenancy under state and local landlord-tenant laws. This new toolkit is one of several guides that communities and providers can reference when creating, operating, or assessing the quality of permanent supportive housing. ### RESULTS OF EVALUATION OF S.F. HOUSING PROJECT FOR DRUG COURT CLIENTS

In 2008, with the support of a Bureau of Justice Assistance (BJA) grant, San Francisco Collaborative Courts implemented a new transitional housing program for Drug Court clients. The Court completed a pilot study to evaluate the success of the program.

The results are as follows:

- Drug Court Transitional Housing Program residents stayed in Drug Court **72 days longer** than the comparison group.
- This represents a **48 percent increase** in treatment days. Higher retention rates predict lower rates of recidivism.
- Transitional housing **increased the graduation rate by 60 percent**. Supportive housing plays a key role in participant outcomes.

One of the goals of San Francisco Collaborative Courts is to work with local and national policymakers to demonstrate the importance of providing housing for people exiting incarceration. It is an essential program component for our clients. We will continue to seek opportunities for continual funding and new partnerships.
