### **MORE HELP FOR VETERANS ON THE WAY**

### **Applications Now Being Accepted for NDCI's Drug Court Planning Initiative**

NADCP's National Drug Court Institute is pleased to announce that applications are now being accepted for the Drug Court Planning Initiative (DCPI). DCPI is the world's leading comprehensive Drug Court training and is designed to give communities the tools and strategies they need to implement high-performing, sustainable programs.

The DCPI is sponsored by the [Bureau of Justice Assistance](#) (BJA), U.S. Department of Justice. Applications are currently being accepted in two categories:\* Adult Drug Court and Tribal Healing-to-Wellness Court. DCPI is designed to fulfill three interconnected goals:

- Educate teams about the basic components of these courts
- Provide teams with the skills necessary for successfully making the shift from standard case processing to treatment court case processing
- Working with teams to build their program to integrate court and treatment functions

DCPI is a six-month process, with each team required to complete pre-training worksheets, attend a five-day Adult Drug Court or Tribal Healing to Wellness training program, maintain routine correspondence with program staff, and submit a implementation plan/draft policy and procedure manual. Up to 10 jurisdictions will be served through the Adult Drug Court Planning Initiative and up to 10 jurisdictions will be served through the Tribal Healing to Wellness Court Planning Initiative. Once capacity is reached, a waitlist will be initiated. Waitlisted teams will be accepted into the Adult Drug Court Planning Initiative or Tribal Healing to Wellness Court Planning Initiative as space becomes available.

All members of a planning team must be able to attend a five-day training program and participate in required distance learning sessions before and after the onsite training. Registration is FREE, however teams will be asked to cover transportation costs.
