On February 24, 2020, this Court issued its *Decision, Order, and Entry Sustaining Plaintiff's Motion for Summary Judgment*, in which Defendant Gregory T. Ackerman was declared a vexatious litigator under O.R.C Section 2323.52. Accordingly, Defendant Gregory T. Ackerman is hereby prohibited from doing one or more of the following without first obtaining leave of the Montgomery County Common Pleas Court to proceed:

- (a) Instituting legal proceedings in the Montgomery County Court of Common Pleas;
- (b) Continuing any legal proceedings that Defendant Gregory T. Ackerman had instituted in the Montgomery County Common Pleas Court prior to the entry of this *Entry and Order Re: Vexatious Litigator Status*; and
- (c) Making any application, other than an application for leave to proceed under O.R.C. Section 2323.52 (F)(1), in any legal proceedings instituted by him or another person in any of the Montgomery County Common Pleas Court.
