
IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED pursuant to R.C. §2323.52(D)(c) Vincent Dobrski is prohibited from making any application, other than an application for leave to proceed under division (F)(1) of R.C. §2323.52, in any legal proceedings instituted by Vincent Dobrski or another person in the court of claims, court of common pleas, municipal court, or county court;

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that Vincent Dobrski is prohibited from instituting or continuing any legal proceedings in the court of appeals without first obtaining leave from the court of appeals pursuant to R.C. §2323.52(F)(2).


