MOTION TO REQUEST TRANSMITTAL OF THE RECORD AND REQUEST FOR
EXPEDITED CONSIDERATION

Pursuant to S. Ct. Prac. R. 14.4 and S. Ct. Prac. R. 18.4, Defendant-Petitioner Ford Motor Company and Defendant-Petitioner TRW Vehicle Safety Systems Inc. (“Petitioners”) move the Court for an order requesting transmittal of the underlying record from the pending Case No. 1:10-cv-00679 in the U.S. District Court, Southern District of Ohio, Western Division.

In the Certification Order (attached as “Exhibit A”), Judge Beckwith stated that the “record before this Court” contained “relevant information to be considered in determining the certified question.” Certification Order, 4.
