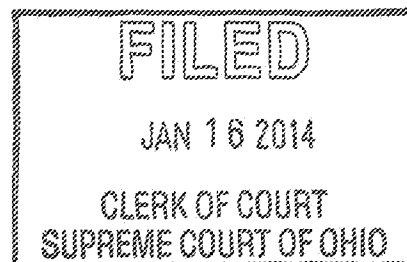
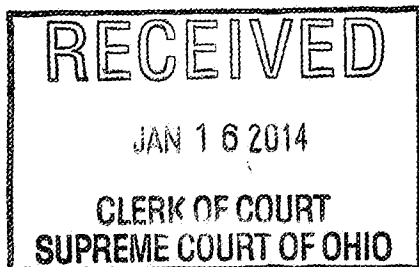




**APPELLANT REQUEST FOR AN EXTENSION OF TIME TO FILE


