

MEMORANDUM

Relator/Appellant Harold Stith pursuant to S.Ct.Prac. R.

3.03(B)(2)(a)(ii) requests an extension of 20 days until March 25, 2017 for the filing of Relator's/Appellant's Reply brief for the reasons as enumerated below:
