**REQUEST ISSUANCE FOR CAPIAS WARRANTS FOR EDWARD BLUNT & JAMIE BLUNT & AND SEARCH WARRANTS FOR THEIR BMV RECORDS, U.S. POSTAL ADDRESS: SEARCHING FOR SPERM & SEMEN IN THEIR FURNITURE AND BEDDING AND IN THEIR VEHICLE: DNA SPECIMEN COLLECTION PROCEDURE TO PROVE GROSS SEXUAL IMPOSITION ORC-2907.05**

Plaintiff must show just cause for request of Capias warrants and search warrant of **Franklin County Children Service (FCCS) & Children's Hospital** medical examination for sexual assault records dating back to 2011: for **ORC 2907.05**, and **ORC-2901.07 DNA** specimen collection procedure of four (4) minor children and for the following individuals:

Plaintiff is requesting Judge Issue search warrants for *sperm semen* inside of Defendants homes on their furniture, mattresses, bedding looking for DNA specimen to prove Gross Sexual Imposition of four (4) minor children named above who reside at the following place of residence:

- 679 South Napoleon Avenue, Whitehall, Ohio 43213, (614) 749-3160
- Vehicle White 1500 Explorer License Plate (**GEY1382**)

Plaintiff must show just cause: Plaintiff witnessed a visible four (4) inch wide hole, in three (3) year old **Isaiah Blunts** rectum, after (all) three (3) children spent the night with **Grandfather Charles Douglas Blunt** located at 2766 East Sixth Avenue, Columbus, Ohio 43219, (614) 258-6822 home. Plaintiff called Father Edward Blunt Senior and requested he come immediately and see this hole in his toddler Son Isaiah Blunts rectum, and take him to **Children's Hospital** emergency room, and have Charles Blunt arrested immediately! We regret **Edward Blunt Senior** lied, and never get the boy examined in his rectum, and we have called police too many times, and police failed to take the children to Children's Hospital to get examination for sexual assault. Plaintiff has contacted **Franklin County Children Service (FCCS)** who lie and say they've examined the children. Janaiah Blunt say's (all) the adults rape them, because they love them: Plaintiff said, "They do not love you!" We are requesting medical examination records of (all) four (4) children by Franklin County Children Service (FCCS) since 2011, and Children's Hospital medical records of sexual examinations.

**Edward Blunt Junior** said, "Father Edward Blunt Senior" also rape (all) four (4) of them. Now, parents Edward Blunt & Jamie Blunt keep dropping the kids off to spend the night with Grandfather Charles Douglas Blunt in his bed, and charged texted me and the message said, he had three (3) kids in his bed; and Plaintiff called police and showed them the text message, and still they will not take the children to Children's Hospital for sexual examination. We have many, many police reports dating back to 2001: when relatives (**Dawn & Lisa Crosby & Sister**) try to kill the Plaintiff.

**Cruel and Unusual punishment**, do apply in this case. **ORC-2923.01**, to commit **ORC-2903.02** and **Attempted Murder**, because (all) adults who have unknown contagious, dangerous infectious diseases: **ORC- 3701.24, ORC-941.07, ORC-3701-3, ORC-3707.57**. We would like charges with offenses named above for **Cruel and Unusual punishment. ORC-2323.13** **Warrant of Attorney to confess. ORC-2323.12 Judgment by confession. If Defendants will confess in the courtroom God will forgive them.**
