### **NOTICE OF APPEAL TO BE CONSOLIDATED WITH CASE NO: GEN-2017-1009 BECAUSE NOT ENOUGH ROOM ON THE FACE OF COMPLAINT FOR (ALL) DEFENDANTS LISTED IN THE LOWER COURT DECISIONS**

Supreme Court Clerks refused to efile over the counter Notice of Appeal or Amended Notice of Appeal. Plaintiff filed one (1) Notice of Appeal over the counter & clerks file stamped it with a big red, file stamp and refused to efile it: it's not on the docket, but they say it is. So, Plaintiff efiled a Notice of Appeal, but clerks didn't put (all) Defendants on the docket, because they wanted the Defendants on the face of the Amended Notice of Appeal, and their example in the book doesn't give enough space to list all the Defendants from lower court room, or (all) third party Defendants listed within the documents. So, Plaintiff filed an Amended Notice of Appeal with more Defendants listed on the face of the Notice of Appeal; but with addresses, there isn't enough room for (all) the Defendants. So, we have filed an additional Notice of Appeal to be consolidated with case number named above; however, on the docket the case no appears **GEN-2017-1009**, and **GEN** is not a category listed in the Supreme Court Rules, which makes it hard to find. Also clerks refused to add all Defendants listed on the lower case decisions, and clerks say that it's impossible for Plaintiff to add Defendants on line, be efile from her computer. If Defendants are not listed on the docket as Defendants Attorneys can argue they are not on case. **Therefore**, there can be no Motion Default which is in order, according to Ohio law, and Defendants cannot be ordered by the court to pay relief in the amount of \$76,000.00. Judgement is not in Order against those Defendants not listed on the docket to face Jury Trail. Also, Defendants are not in conspiracy with other Defendants, because they are not listed as Defendants on the docket. **Therefore**, Plaintiff has to file another complaint and consolidate it to Amended Notice of Appeal to list all the Defendants on the face of the complaint; and not lose

Motion Default Judgement. It appears that courts are not in favor of Minorities winning in the courtroom.

We have filed a new Notice of Appeal and we have listed all Defendants within the Lower Case Decisions, as much as we can, and request cases be consolidated together. These many cases were already consolidate in civil courtroom and domestic court room by **Judge Patrick Sheeran, Judge James W. Brown, and Guy L. Reece II**, already on the docket with their addresses listed in their certificate of services. Clerks says they don't review lower case decisions, or review their certificate of service, or their case numbers. So, we have listed them on the face of Notice of Appeal; since they are in questions by **Ohio Attorney General Stefan Schmidt from Mike DeWine's Office** who lied in the court room committing perjury three (3) times, stating Plaintiff has filed hundreds and thousands upon thousands of complaints to their court system: we want them to *show just cause* why they committed perjury in the courtroom.

Defendants have not answered this Amended Notice of Appeal from **GEN-2017-1009 therefore**, Motion Default is in order according to Ohio Law August 28<sup>th</sup>, 2017, and since many Defendants were not listed on the docket Attorneys argued they are a Defendant: and requested clerks return Plaintiffs motions and take them off the docket. Therefore, we filed an addition Notice of Appeal with more Defendants listed on the face of the complaint; with two (2) pages requesting Jury Trail be set. Plaintiff is requesting the death penalty, and Jury Trail must be set. According to the **Constitution of the United States of America, Bill of Rights, Eight Amendment Cruel and Unusual Punishment** do apply in these cases, and we're requesting the death penalty, and we need Jury trial scheduled upon receiving this complaint: **ORC-2945.17 Right to jury trial, ORC-2743.11, ORC-2107.72, House Bill 265 Right to Jury Trial, Rule 38. Right to a Jury Trail.**
