Re: KeyBank National Association

Dear Ms. Baldwin:

As you know, this firm represents KeyBank National Association, and its parent corporation KeyCorp (collectively “KeyBank”). The purpose of this letter is to request that you cease and desist from any further contact with KeyBank or its individual employees.

We have been responding to your inappropriate actions since at least April 2014. The first encounter this office had with you was when you issued a subpoena to KeyBank in the stalking case you filed against the Fifth Third Bank employee, Marc D. Brandt, in Hamilton County Court of Common Pleas, Case Number SK1400227. As you will recall, we objected to your subpoena on numerous grounds on April 8, 2014.

You responded to my April 8th letter that same day asking for help in accessing your “corporate debt bonds that have matured with KeyBank” or setting up a “collateral loan using the trust accounts that I have with KeyBank.” At that time, I had KeyBank research whether any accounts exist in your name. KeyBank searched its records and did not locate any accounts in your name at any time. Thus, this research shows that you do not hold any accounts or other assets at KeyBank.

Despite having no accounts at KeyBank, your conduct persisted with a May 3, 2014 email to the PhillyWebTeam@nbcuni.com with attachments, including my April 8th letter, which appears to be your notification that you intended to initiate legal proceedings against KeyBank. I am not sure what this “PhillyWebTeam” is, but “nbcuni.com” is the webpage for the television network NBC Universal. This email to “the Fourth Team” was then sent to me and other attorneys in my firm that are not involved in any way with KeyBank matters.

Then, you sent an email to the KeyBank Investor Relations Department on May 5, 2014, asserting, among other things, that “KeyBank of Ohio has a murder plot against me in order to

pay billions with trillions of my assets to their employees.” These allegations are obviously false and outrageous. KeyBank does not have a murder plot or conspiracy against you. You then forwarded that same May 3rd email to Matthew Milcetic and Amy Coulson at KeyBank for some strange reason.

Having received no response to your outrageous May 3rd emails, you then persisted in filing a complaint against KeyBank in the U.S. District Court for the Southern District of Ohio. That suit, obviously baseless in its face, was dismissed by the Court on its own without KeyBank taking any action. Further, the Court declared you a vexatious litigation based on filing the frivolous suit against KeyBank and your prior history of filing frivolous lawsuits.

The Federal Court’s dismissal of your case did not seem to deter your conduct, however. Your inappropriate email campaign continued on August 6, 2014, September 11, 2014, and September 24, 2014 to various KeyBank employees. You also placed a telephone call to KeyBank Executive Client Relations on September 17, 2014.

Please be advised that KeyBank does not have any documents or information regarding accounts, financial assets, or financial obligations between you and KeyBank. KeyBank has searched and found nothing. There is no murder plot or conspiracy against you and you don’t have any funds on deposit with KeyBank. Your persistent course of email and telephone contact with KeyBank is disruptive, inappropriate and harassing. On behalf of KeyBank, do not contact it or any of its employees via email, phone or otherwise. If your conduct continues, we will take legal action against you.

If you wish to speak to anyone regarding a KeyBank matter, direct all communication solely to me.
