

COMPLAINT FOR WRIT OF PROHIBITION

I, ERIQ R. MCCORKLE, Relator, do **HEREBY SWEAR UNDER THE PENALTY OF PERJURY AND FALSIFICATION THE FORGOING FACTS ARE TRUE AND CORRECT**. I am of legal age and competent to testify to the same:

FACTS

1. Relator was indicted on or about October 30, 2020 in connection with case number **20-CR-05140**.
2. On or about November 5, 2020 Relator promptly provided notice to the Franklin County Prosecutor pursuant to **R.C. 2941.401. (Exhibit A)**
3. On or about September 27, 2021, the Franklin County Prosecutor applied for a Court Order to "**remove [Relator] from the custody of the Warden of the Southeastern Correctional Institute and deliver him to the custody of the Sheriff of Franklin County.**" See **(Exhibit B)** This was requested pursuant to **R.C. 2941.40; 2941.41; 2941.42**

4. On or about September 27, 2021 an Order was issued to the Sheriff of Franklin County "**directing him to take into custody [Relator]...and remove him to the Franklin County Corrections Center.**" See **(Exhibit C)**
5. On or about September 27, 2021 upon warrant issued, the Franklin County Sheriff's Office was commanded to take Relator from the custody of the Warden of the Southeastern Correctional Institution and "**bring him before me or some other Judge of the Common Pleas Court of Franklin County to answer the indictment in case number 20-CR-05140.**" See **(Exhibit D)**
6. On or about September 28, 2021 a "**Warrant to Convey**", **pursuant to R.C. 2941.41** was ordered and issued to the Sheriff of the Franklin County commanding the him to "**take charge and convey [Relator] to Franklin County Correction Center.**" See **(Exhibit D)**
On or about October 8, 2021 the Franklin County Sheriff's Office executed the "**Warrant to Convey**". **(Exhibit E)**
7. On or about October 20, 2021 Relator was arraigned in connection with case number 20-CR-05140. On or about October 28, 2021 a Trial Date was scheduled for December 9, 2021.
8. **THE DOCKET FAILS TO REFLECT THAT THE FRANKLIN COUNTY SHERIFF RECEIVED AN ORDER FROM RESPONDENT TO RETURN RELATOR TO THE CORRECTIONAL INSTITUTION, PURSUANT TO R.C. 2941.42, ON, OR BEFORE THE DATE TRIAL WAS SCHEDULED.**
9. On OR BEFORE the date Trial was scheduled, December 9, 2021 the Docket fails to reflect a REASONABLE continuance, with the prisoner or his counsel present, pursuant to R.C. 2941.401 and R.C. 2945.72 et seq. See **(Exhibit F)**
10. On or about July 28, 2022 Respondent issued what appears to be an Entry Continuing Trial from December 9, 2021 to August 22, 2022.
11. Respondent asserts that this "*Continuance*" is in accordance with Franklin County Common Pleas Court Local Rules (Rule 79.01).

INJURY

12. The action in Case No. **20-CR-05140** was not brought to Trial with the time provided under **R.C. 2941.401**. Therefore, the Court no longer has jurisdiction thereof.

13. Enter a Writ of Prohibition enjoining Respondent from rendering any Entry accept an Order dismissing the action with prejudice.


14. **Alternative Writ:** Compel Respondent to provide reason as to why the writ should not be granted


