STATEMENT OF FACTS

This case arises due to a violation of Due Process of Law in Criminal Procedure. On August 15, 2016, I KAYLIND SPEARS in the car on 10th Ave with my little brother Jordan Spears. While a police car turned on their lights and pulled us over. My brother was the driver. Whom complied. Not asking for his license. I was the prime target. I was asked to place my hands out the window with my I.D and step out the car, which I did. Asking why am I having to do all this. Officer stated he is authorized to take me to the police head quarters for questions. After being placed in a isolated room awaiting the interview, DETECTIVE Phillip Thomas entered and began to question me about a robbery that took place on August 11, 2016, at a "metro PCS" and what was said to be one hundred twenty dollars stolen. Whereas nothing was linking me to the crime scene, other than a disgruntled family member of her suspicions seeking a reward. Because I had a similar "wine hoodie", on Facebook. After further more question, from DET Phillip Thomas. I then stated that I was at a late friends party with a female name Molly Hines. then stated my 5th Amendment. Though I remained in custody with no warrant issued to me to even apprehend me. This is a violation of my 4th Amendment. DET Phillip Thomas then leaves me in the isolated room for what seem to be hours. I began singing loud songs. Then began to bang my head up against the wall. This is what made DET Phillip Thomas return to the room I was placed. along following him were other officers, placing hand cuffs on me attaching me to a bench. This is where the alledge spitting came from, on DET Phillip Thomas. That night I was taken to Franklin County detention and was booked in on 8-15-16 or 8-16-16. Reviewing my case history, no warrant was issued till 8-24-16. A arraignment was scheduled 8-24-16, before the indictment was filed 8-24-16. Warrant returned served 8-25-16. And on my "TRUE BILL" indictment it states as followed; "The jurors of the grand jury of the state of Ohio, duly selected, impaneled, sworn and charged to inquire of crimes and offenses committed within the body of

Franklin County in the state of Ohio upon their oath do find and present that KAYLIN DASHAWN HAMPTON-SPEARS LATE OF said County On or about August 11, 2016. The word "LATE" implying to Dead or Absent. IF Said Person Henceforth is "LATE" which i **stated** prior. **Who AM I?** Also if this was Served to me on 8-11-16, why was i picked up for questioning on 8-15-16. When the warrant wasn't issued until 8-24-16, Along with the filing of my Indictment. This is a violation of my 8th & 14th Amendment Because i was detained for 9 or 8 days until proper court procedures took place in due process. As stated on my "Case History" VIA, By being I competent i was sent to a mental health facility. Placed on numerous medication which impaired me. Then sent back to Franklin County detention still under the influence of numerous medication. Then faced competency to stand trial. On 4-27-17. After firing my first public defender Michael W. Morgan, Then was issued a pro-bono named Robert Krapenc whom is an Ex-prosecutor. which i believe is a conflict of interest. Due to reasons of he previously worked with Scott Kirschman, who also at the time was the prosecuting Attorney on this case. which DET Phillip Thomas had a great influence on Scott Kirschman on this case in multiple court settings. And DET Phillip Thomas was a "victim". Robert Krapenc whom is my pro-bono Coerced me to sign the guilty plea, stating if i keep stating not guilty, they will find me guilty in trial and give me a lot amount of time. As well promising me with the Judge William Woods, he will sentence me to 7-8 years. But once at my Sentencing hearing i was sentence to 17 years (16cr-4614 was ran consecutive but was ran concurrent to 16cr-4615 and 17cr-6097. On my Judgment Entry") though i feel case number "16cr-4614" should have been ran concurrent. due to being Allied offences. I also believe i was not given a fair chance, due to the fact. I had a white judge, prosecutor, Pro-bono, Detective etc. that kind of Resembles Strauder vs. West Virginia

STATEMENT OF RELIEF

The relief being sought is my "freedom" as well "SOVEREIGNTY
DUE TO REASONS LISTED BELOW.

Now as I explain, I AM known as KAYLIN DASHAWIN HAMPTON-SPEARS this name that I AM known as is void. And not who I truly AM. for numerous of reasons, for (1); Being that this name in all capitalize letters indicates a "Charter Contract", explained within the "BLACKSTONE PARALEGAL STUDIES" Constitutional Law Part II. And a "Corperation", which I AM not a Corperation. for I was "Impaired" when I was sent to a mentle health facility. (STATED on my Case History), and was induced with fear and as well "Coercion" by Pro-bono Robert Krapenc also known as Ex-prosecutor to enter a guilty plea with a broken promise of 7-8 years. knowing I was ignorant of the law. Even from the beginning of being question by DET/Victim Phillip Thomas, where my 4th, 5th, 8th, 14th Amendment was violated. And now warrant was given to even apprehend me from the start. (2); The STATE vs KAYLIN D. HAMPTON-SPEARS, Henceforth the STATE vs KAYLIN D. HAMPTON-SPEARS. How can the STATE OF OHIO, which STATE means organized body of people for political purpose, Occupying permanently a fixed territory and possessing an organized government capable of making an Enforcement Law within the community. So how can the STATE OF OHIO be against me, when I ALLEGEDLY known as KAYLIN D. HAMPTON-SPEARS never victimize the STATE, which this STATE OF OHIO is a "Quasi-Contract and Quasi-Corperation": which I by right as a fidenginous men by rights of the Land, being a "IROQUOIS", Native American Indian, Tribe of Cherokee. Since June 11, 1776 an Onondaga Indian tribeman Name "Sachem" gave "John Hancock" the IROQUOIS (IRA-COY) Name "KARANDUAWN", or the Great Tree. At independence Hall, between us and the Europeans treaty which yall later reversed, which the dollar bill symbolizes it. Even stated on the Constitution (We the People) IF I AM a part of the people, why

Shouldn't it have been FADEL HARBI VS KAYLIND D. HAMPTON-SPEARS or METRO PCS VS KAYLIND D. HAMPTON-SPEARS. Because they are the accusers whom never points me out or comes to court to testify on his own behalf, but sends a digit link to prosecutor "Scott Kirschman" whom also represent the STATE OF OHIO. which is a corporation in Capital Letters of a Private Confederacy of Commerce Law Looking at the individual person(s) as property, Goods, Stock, Bonds, etc. So how can Scott Kirschman represent the STATE OF OHIO. knowing its other cities in OHIO with their own prosecutors. When his Licences, ID, Birth Certificate or Social Security doesn't implement him as the STATE OF OHIO, which is a silent private corporation in the order of Great Brittan. 

JUDGMENT ENTRY
(Prison Imposed)

On November 27, 2017, the State of Ohio was represented by Assistant Prosecuting Attorney Scott Kirschman and the Defendant was represented by Attorney, Robert Krapenc. The Defendant, after being advised of his rights pursuant to Crim. R. 11, entered a plea of guilty to Count One of the Indictment, to wit: Harassment with a Bodily Substance, in violation of Section 2921.38 of the Revised Code, a Felony of the Fifth Degree.

The Court found the Defendant guilty of the charge to which the plea was entered.

The Assistant Prosecuting Attorney and the Defendant's Attorney jointly recommended a sentence that this case and 17CR-6097 run CONCURRENT to 16CR-4614.

The Court ordered and received a pre-sentence investigation.

On January 12, 2018, a sentencing hearing was held pursuant to R.C. 2929.19. The State of Ohio was represented by Assistant Prosecuting Attorney Scott Kirschman and the Defendant was represented by Attorney, Robert Krapenc.

The Court afforded counsel an opportunity to speak on behalf of the Defendant and addressed the Defendant personally affording Defendant an opportunity to make a statement on Defendant's own behalf in the form of mitigation and to present information regarding the existence or non-existence of the factors the Court has considered and weighed.

The Court has considered the purposes and principles of sentencing set forth in R.C. 2929.11 and the factors set forth in R.C. 2929.12. In addition, the Court has weighed the factors as set forth in the applicable provisions of R.C. 2929.13 and R.C. 2929.14. The Court further finds that a prison term is not mandatory pursuant to R.C. 2929.13(F).

The Court hereby imposes the following sentence: TWELVE (12) MONTHS as to Count One at the OHIO DEPARTMENT OF REHABILITATION AND CORRECTIONS. Sentence is to be served CONCURRENT to Case Numbers 16CR-4614 and 17CR-6097.

Exhibit (B) 3

The Court has considered the Defendant's present and future ability to pay a fine and financial sanction and does, pursuant to R.C. 2929.18, order the following fine and/or financial sanctions: Defendant declared indigent. No fine or costs imposed.

The total fine and financial sanction judgment is \$0.

After imposing sentence, the Court stated its reasons as required by R.C. 2929.19.

After the imposition of sentence, the Court notified the Defendant, orally and in writing, that the applicable period(s) of post-release control pursuant to R.C. 2929.19(B)(2)(c), (d) and (e) is up to three (3) years optional. To the extent that the imposition of post-release control is to be determined by the Adult Parole Authority, the Court hereby notifies said Authority that, in the opinion and recommendation of the Court, post-release control be imposed. The Defendant was informed, orally and in writing, that if the Defendant violates post-release control, the Adult Parole Authority has discretion under R.C. 2967.28 to extend the amount of time that the Defendant spends on post-release control; or that it may add additional conditions to the existing post-release control; or that the Defendant's sentence **will** be extended administratively, should the Adult Parole Authority so determine, in accordance with State law, for a period not to exceed one-half of the sentence imposed by this Court. In addition, the Court notified Defendant that if Defendant is convicted of a new felony offense while Defendant is on post-release control, in addition to being punished for the underlying conduct, an additional prison term of one year or the remainder of Defendant's post-release control term may be added as a consecutive penalty.

The Court makes no recommendation of the offender's placement in an intensive program or Transitional Control or Risk Reduction Sentence.

Based upon the stipulation of counsel, the Court finds as a matter of fact the Defendant has 516 days of jail time credit and hereby certifies the same to the Ohio Department of Corrections. The Defendant is to receive jail time credit for all additional jail time served while awaiting transportation to the institution from the date of the imposition of this sentence.
